Is there a need?

- In 2008, **2.5 million** people were diagnosed with cancer in the EU.
- Cancer is the second most common cause of death in the Union – a figure that is expected to rise due to the ageing European population.
- The most frequently occurring forms of the disease in the EU are colorectal, breast, prostate and lung cancers.
- Europe is also characterised by worrying inequalities in cancer control and care, existing within, as well as between, EU Member States. (Taken from: http://ec.europa.eu/health/major_chronic_diseases/diseases/cancer)

EPAAC'S GOAL: Helping to reduce cancer incidence by 15% by 2020

EPAAC ID CARD

- A type of project (Joint Action) co-financed by the EU
- Led by National Institute of Public Health, Slovenia, Coordinator: Sandra Radoš Krnel
- 36 associated partners from across EU, over 100 global collaborating partners
- Started in February 2011, ends in February 2014
- What will we do? In one sentence:

EPAAC will contribute to the reduction of the cancer burden in the EU through various initiatives & to support Member States in the development of their National Cancer Plans.

Awareness, positive changes in behaviour

- To raise awareness about cancer recognizing that "prevention offers the most cost-effective long-term strategy for the control of cancer"
- To re-launch the annual European Week Against Cancer (EWAC) targeting policy-makers at European, national and sub-national levels as key participants
- To optimise the use of tools to communicate proven prevention strategies that can be translated and adapted for use in different Member States
- To target vulnerable population groups such as women and children.

Early diagnosis of cancer

- Improve implementation of the Council Recommendation on Cancer Screening
- Promote synergy between cancer screening and other areas of early detection
- Initiate a network of European Schools of Screening Management
- Establish a comprehensive training course in management of cancer screening programmes
- Identify inequalities in cancer screening programmes
- Facilitate expert advice to regions seeking to improve cancer screening programmes
- Develop a consensus on quality criteria for health checks

Better Quality Healthcare

- Promote the exchange of experiences and best practices across European health services
- Develop, review and harmonize Clinical Guidelines (harmonization of clinical guidelines in sarcomas as a case study of a rare tumor; clinical guideline at EU level regarding nutritional recommendations for cancer patients during the treatment of the disease.)
- Implement a training strategy to improve psychosocial and communication skills among health care providers

European Standards of Care for Children With Cancer

- Conference: 20-21 October 2011, Warsaw
- Goal: to improve the quality of care of children and adolescents with cancer as well as to assess the relevant organisational aspects in paediatric oncology
- What happened? **Discussions of implementation of such** standards at national level

More Efficient Cancer Research


- Identify and prioritize areas in cancer research that will benefit from coordination
- Develop a concerted approach for coordination of one third of research from all funding sources by 2013
- Implement pilot projects of research coordination in selected areas

Empowerment, more information

Empowerment through Information

- Map the main sources of cancer data
- Unify cancer burden indicators (incidence, mortality, survival and prevalence)
- Promote a European task force aimed to asses the need for data on cancer costs
- Initiate development of a standardised approach to the routine collection of data on survivorship
- Develop an inventory of statistical methods to analyse population-based cancer data

What 's in it for the EU Member State?

COORDINATION (bringing together EU stakeholders in one initative) INFORMATION (EU Data map for better comparison, important for EU policy makers)



HELP WITH CANCER STRATEGY (National Cancer Plan) The National Cancer Plan is a public health programme designed to ensure coordinated and centrally managed implementation of evidence-based strategies for :

- Guidelines for a high level standard NCP and the respecting indicators
